ITEMS ACCEPTED INTO THE CONSIGNMENT PROGRAM WILL BE LISTED ON OUR [CONSIGNMENT](#) PAGE & FEATURED IN PERIODIC SOCIAL MEDIA POSTS TO DRIVE TRAFFIC TO THE CONSIGNMENT SITE.

ITEM REQUIREMENTS:

- CURRENT (OR TIMELESS) IN STYLE
- HIGH QUALITY MANUFACTURERS CONSISTENT WITH THE QUALITY SOLD BY ARTISAN DESIGN STUDIO. ANTIQUES IN GOOD OR GREAT CONDITION ARE WELCOMED.
- NEW OR ALMOST NEW CONDITION (ANY FLAWS OR DEFECTS MUST BE SHOWN IN PHOTOGRAPHS AND DESCRIPTION OF THE ITEM UPON APPLICATION). CONDITION OF ANTIQUES MAY VARY AND CAN BE DISCUSSED UPON REVIEWING APPLICATION.
- UPHOLSTERY ITEMS AND RUGS MUST BE FREE OF STAINS & MUST BE PROFESSIONALLY CLEANED (RECEIPT REQUIRED) PRIOR TO INSPECTION FOR ACCEPTANCE.
- ITEMS THAT HAVE FUNCTIONING PARTS (DRAWERS, ELECTRONIC ELEMENTS, ETC) MUST ALL BE IN PERFECT WORKING ORDER.
- DIMENSIONS & PHOTOGRAPHY MUST BE SUPPLIED, AS WELL AS YOUR REQUESTED SALES PRICE. PHOTOS MUST BE IN GOOD LIGHTING, WITH ITEMS REMOVED FROM ALL SURFACES TO ENSURE CLEAR PHOTOGRAPHY.
- ITEMS MUST BE ACCESSIBLE FOR ARTISAN APPROVAL OF CONDITION PRIOR TO ACCEPTANCE INTO THE CONSIGNMENT PROGRAM.
- ITEMS CANNOT BE SUBJECTED TO DAILY USE FOLLOWING ARTISAN INSPECTION (MUST BE STORED IN CLEAN, CLIMATE-CONTROLLED AREA WHERE ITEM WILL NOT SUSTAIN ADDITIONAL WEAR, SOIL OR DAMAGE)
- PURCHASER MAY REQUEST IN-PERSON INSPECTION PRIOR TO PURCHASING ANY ITEMS

PRICING:

- ARTISAN WILL DETERMINE A PRICE AT FAIR RESALE MARKET VALUE. LIKE YOU, WE WANT TO GET THE MOST WE CAN FOR YOUR TREASURES. WE ENCOURAGE YOU TO PROVIDE AS MUCH INFORMATION AS POSSIBLE, SUCH AS THE MANUFACTURER, ORIGINAL COST (WITH RECEIPT WHEN POSSIBLE) AND AGE OF YOUR PIECES, AND WE WILL USE OUR EXPERTISE ON CURRENT MARKET PRICES TO PRICE YOUR ITEMS. SELLER HAS THE RIGHT TO DISCONTINUE CONSIGNMENT PROCESS IF SALES PRICE IS NOT AGREED UPON PRIOR TO CONSIGNING THEIR ITEMS.
- SELLER MAY REQUEST THAT AN ITEM BE REMOVED FROM THE CONSIGNMENT PROGRAM IF AN ITEM IS REDUCED TO AN AGREED UPON SALES AMOUNT
- ITEMS WILL BE REDUCED IN PRICE BY 10% APPROXIMATELY EVERY 60 DAYS (ON THE FIRST OF EACH MONTH) AND ARE SUBJECT TO REMOVAL FROM THE PROGRAM IF NOT SOLD AFTER 6 REDUCTIONS (12 MONTHS). AT THE END OF THE 12-MONTH PERIOD, IF AN ITEM IS IN ARTISAN'S POSSESSION, THE ITEM MUST BE PICKED UP WITHIN 14 DAYS OR THE ITEM WILL BE DONATED TO A CHARITY OF OUR CHOOSING.
- ARTISAN RETAINS 40% OF FINAL SALES PRICE, LESS ANY FEES INCURRED (DELIVERY, ETC) REGARDLESS OF NUMBER OF MARKDOWNS.
- ARTISAN ASSUMES PICKUP AND DELIVERY WILL BE HANDLED BY THE SELLER. IF DELIVERY SERVICES ARE NEEDED, ARTISAN IS HAPPY TO HELP WITH DELIVERY TO PURCHASER AT AN ADDITIONAL FEE.
- SALES TAX WILL BE APPLIED TO EACH ITEM IN ACCORDANCE WITH STATE SALES TAX GUIDELINES

CONSIGNMENT CHECKS FOR SOLD MERCHANDISE WILL BE MAILED TO PROVIDED ADDRESS WITHIN 30 DAYS OF SALE
